



2024 Enrollment Scenarios for Humana Hospice VBID

Existing Humana Hospice VBID Member Scenarios:

Members already covered on a Hospice VBID plan during year 3 (2023) of the Hospice VBID demonstration.

Scenario:	Member enrolled in H5216-266-000 for plan year 2022, elected hospice during 2022, and continued H5216-266-000 in 2023 and for 2024 without any revocation/discharges.	Member enrolled in H5216-266-000 for plan year 2022, continued on H5216-266-000 for 2023 and 2024 and was not on hospice as of 1/1/2023 or 1/1/2024.	Member enrolled in H5216-019-000 for plan years 2022 or 2023, elected hospice during 2022 or 2023 and continues hospice care as of 1/1/24 and remains enrolled in H5216-019-000 for 2024.
VBID Coverage:	Member Hospice VBID coverage will continue into 2024 until such time as the member revokes or is discharged from hospice	The member is eligible for hospice care under Original Medicare. Hospice VBID coverage is not available under this plan in 2023 or 2024.	Member Hospice VBID coverage will continue into 2024 until such time as the member revokes or is discharged from hospice

Hospice Provider Responsibility:	Hospice provider will continue to bill Humana for the member’s hospice care until the member revokes or is discharged from hospice. Kentucky market: H5216-019-000 Year 2 and Year 3 plan. In 2024, H5216-019-000 no longer offered as a Hospice VBID plan. Any member currently enrolled in hospice since 2022 or 2023 AND re-enrolls in H5216-019-000 for 2024 will be continued on Hospice VBID program until such time as they are discharged or revoke.

Virginia market: H5216-266-000 any member that elected hospice in 2022 and is still living in 2024 (provided no discharge or revocation) AND re-enrolls in H5216-266-000 in 2024 will continue coverage by Humana.

Virginia market: H5619-139-001 and H5619-139-002 are year 2 and 3 participating plans. In 2024, neither of those 2 plans will be offered by Humana and are being consolidated into H5619-157-000, which is a 2024 VBID plan. Member hospice coverage will continue only if they choose a 2024 participating plan.

Virginia market: H5619-140-001 and H5619-140-002 are year 2 and 3 participating plans. In 2024, neither of those 2 plans will be offered by Humana and are being consolidated into H5619-157-000, which is a 2024 VBID plan. Member hospice coverage will continue if they choose a 2024 participating plan.

Virginia market: H6622-005-000 was a Year 1,2,3 participating plan. In 2024, it is no longer being offered by Humana and is being consolidated into H6622-004-000 which is a 2024 participating plan. Member hospice coverage will continue only if they choose a 2024 VBID plan.

Wisconsin market: H6622-034-000 was a year 3 participating plan. In 2024, it is no longer being offered by Humana and is being consolidated into H6622-001-000 which is a 2024 participating plan. Member hospice coverage will continue only if they choose a 2024 VBID plan.
