

Humana Healthy Horizons in Louisiana OB-GYN Provider Resource Guide

Preventive health

Humana Healthy Horizons® in Louisiana will provide coverage for 1 well-woman gynecological examination per year, with no prior authorization or referral, for women ages 21 years and older, when performed by the member's primary care provider (PCP) or in-network gynecologist. This is in addition to 1 preventive medical visit for adults ages 21 years and older.

Prenatal visits

2 initial prenatal visits per pregnancy are covered (270 days). A pregnancy-related diagnosis code must be used on the claim form as either the primary or secondary diagnosis. Prenatal services should be billed with a TH modifier.

Codes to identify prenatal visits for Medicaid

CPT-II

0500F—Initial prenatal care visit (report at first prenatal encounter with healthcare professional providing obstetrical care. Report also date of visit, in a separate field, and date of the last menstrual period [LMP])

0501F—Prenatal flow sheet documented in medical record by first prenatal visit (documentation includes at minimum blood pressure, weight, urine protein, uterine size, fetal heart tones and estimated date of delivery); report also date of visit and date of the LMP (Note: If reporting 0501F prenatal flow sheet, it is not necessary to report 0500F initial prenatal care visit.)

0502F—Subsequent prenatal care visit (prenatal); excludes patients who are seen for a condition unrelated to pregnancy or prenatal care¹

Obstetric ultrasounds

3 obstetric ultrasounds shall be reimbursed per pregnancy (270 days) without the requirement of prior authorization or medical review when performed by providers other than maternal fetal medicine specialists.

Postpartum care visit

The postpartum care CPT code, which is not modified with TH, may be billed for the postpartum care visit when performed. Reimbursement is allowed for 1 postpartum visit per 270 days.¹

59430—Vaginal delivery antepartum and postpartum care procedures

Tobacco cessation services

During the prenatal period through 60 days postpartum, Humana Healthy Horizons covers up to 4 tobacco cessation counseling sessions per quit attempt, up to 2 quit attempts per calendar year, for a maximum of 8 counseling sessions per calendar year. The TH modifier must be included on claims for tobacco cessation counseling during the prenatal period. The TH modifier should not be used for these services during the postpartum period.

HumanaBeginnings prenatal program

The HumanaBeginnings® program provides perinatal and neonatal care management utilizing a specialized staff. Nurses are available to help manage high risk pregnancies and premature births by working in conjunction with providers and members.

Family planning

Members, including adolescents, may receive family planning services and related supplies from appropriate Medicaid family planning providers regardless of network status, participating or nonparticipating. These services do not require a referral or prior authorization.

Long-acting reversible contraception (LARC) devices are covered when provided in the postpartum period prior to discharge. Hospitals shall bill for an LARC device separately from the inpatient stay. Reimbursement for LARC devices inserted in the outpatient hospital setting is in addition to the outpatient hospital reimbursement. Hospitals shall bill the durable medical equipment (DME) revenue code of 290 with the appropriate HCPCS code for the LARC device on the UB-04.
