# Limitations and exclusions

This is an outline of the limitations and exclusions for this Humana individual dental plan. It is designed for convenient reference. Consult the policy for a complete list of limitations and exclusions. In addition to any limitations and exclusions listed in "Schedule of Policy Benefits" or "Definition" sections, this policy does not provide benefits for the following:

- 1. Any expenses incurred while you qualify for any worker's compensation or occupational disease act or law, whether or not you applied for coverage.
- 2. Services:
  - a. That are free or that you would not be required to pay for if you did not have this insurance, unless charges are received from and reimbursable to the U.S. government or any of its agencies as required by law;
  - b. Furnished by, or payable under, any plan or law through any government or any political subdivision (this does not include Medicare or Medicaid); or
  - c. Furnished by any U.S. government-owned or operated hospital/institution/agency for any service connected with sickness or bodily injury.
- 3. Any loss caused or contributed by:
  - a. War or any act of war, whether declared or not;
  - b. Any act of international armed conflict; or
  - c. Any conflict involving armed forces of any international authority.
- 4. Any expense arising from the completion of forms.
- 5. Your failure to keep an appointment with the dentist.
- 6. Any services that are considered cosmetic unless due to accidental injury sustained while you are covered under the policy. The following procedures are considered cosmetic:
  - a. Facings on crowns or pontics (the portion of a fixed bridge between the abutments) posterior to the second bicuspid;
  - b. Services to correct congenital malformation in which caries/decay is not present;
  - c. Service performed to improve appearance in which caries/decay is not present;
  - d. Characterizations and personalization of prosthetic devices; or
  - e. Restorative procedures to change the spacing and/or shape of the teeth in which caries/decay is not present.
- 7. Charges for:
  - a. Any type of implant and all related services, including crowns or the prosthetic device attached to it.
  - b. Precision or semi-precision attachments.
  - c. Overdentures and any endodontic treatment associated with overdentures.
  - d. Other customized attachments.
- 8. Any service related to:
  - a. Altering vertical dimension of teeth; Restoration or maintenance of occlusion;
  - b. Splinting teeth, including multiple abutments, or any service to stabilize periodontally weakened teeth;
  - c. Replacing tooth structures lost as a result of abrasion, attrition, erosion or abfraction; or
  - d. Bite registration or bite analysis.
- 9. Infection control, including but not limited to sterilization techniques.
- 10. Fees for treatment performed by someone other than a dentist except for scaling and teeth cleaning, and the topical application of fluoride that can be performed by a licensed dental hygienist. The treatment must be rendered under the supervision and guidance of the dentist in accordance with generally accepted dental standards.
- 11. Any hospital, surgical or treatment facility, or for services of an anesthesiologist or anesthetist.
- 12. Prescription drugs or pre-medications, whether dispensed or prescribed.
- 13. Any service not specifically listed in **your plan benefits**.
- 14. Any service shown as "Not Covered" in the Schedule.



## Limitations and exclusions (continued)

#### 15. Any service that we determine:

- a. We determine are not eligible for benefits based upon clinical review;
- b. Do not offer favorable prognosis as determined by the treating provider;
- c. Do not have uniform professional endorsement as determined by the treating provider; or
- d. Is deemed to be experimental or investigational as determined by the treating provider.
- 16. Orthodontic services.
- 17. Any expense incurred before your effective date or after the date your coverage under the policy terminates except as provided in the Extension of Benefits provision.
- 18. Services provided by someone who ordinarily lives in your home or who is a family member.
- 19. Charges exceeding the reimbursement limit for the service.
- 20. Treatment resulting from any intentionally self-inflicted injury or bodily illness.
- 21. Local anesthetics, irrigation, nitrous oxide, bases, pulp caps, temporary dental services, study models, treatment plans, occlusal adjustments, or tissue preparation associated with the impression or placement of a restoration when charged as a separate service. These services are considered an integral part of the entire dental service.
- 22. Repair and replacement of orthodontic appliances.
- 23. Any surgical or nonsurgical treatment for any jaw joint problems, including any temporomandibular joint disorder, craniomaxillary, craniomandibular disorder or other conditions of the joint linking the jaw bone and skull; or treatment of the facial muscles used in expression and chewing functions, for symptoms including, but not limited to, headaches.
- 24. Elective removal of non-pathologic impacted teeth.
- 25. Service for orthognatic surgery.
- 26. Services generally considered medical or covered by a medical plan.
- 27. Any services for destruction of lesions by any method.
- 28. Any services for tooth transplantation.
- 29. Any services for removal of a foreign body from the oral tissue or bone.
- 30. Any services for reconstruction of surgical, traumatic, or congenital defects of the facial bones.
- 31. Any separate fees for pre and post-operative care.
- 32. Replacement of restorations (fillings) placed less than two years ago.
- 33. Any service or claim resulting from a prohibited referral as determined by the appropriate regulatory board.
