**Date the plan starts:** Your start date will be the first of the month following the day you enrolled.

### Maximum out-of-pocket

Out of pocket maximum per calendar year for a policy with one covered child is \$450. The out-of-pocket maximum per calendar year for a policy with two or more covered children is \$450 per individual child or \$900 combined for all children.

† Out-of-network dental providers have not agreed to provide services at contracted fees. The out-of-network provider may bill the member for more than what the plan pays. Members are responsible for this difference between Humana's reimbursement and the out-of-network provider's charges. This is known as balance billing. Benefits received are subject to any benefit maximums, limitations and/or exclusions. Network providers agree to bill us directly. If a provider who is not in our network is not willing to bill us directly, the member may have to pay upfront and submit a request for reimbursement. Waiting periods and other limitations may apply; please see your policy for coverage details.

An individual covered family member will receive benefits for covered services once they have met their individual deductible. The rest of the covered family members will receive benefits for covered services once they have met their individual deductible. The annual maximum benefit for each adult covered family member is shown above. Children age 19 and younger covered on the policy do not have an annual maximum.

## Limitations and exclusions

This is an outline of the limitations and exclusions for this Humana individual dental plan. It is designed for convenient reference. Consult the policy for a complete list of limitations and exclusions. Unless specifically stated otherwise, no benefits will be provided for, or on account of, the following items:

1. Any claims that have been paid while a covered person qualifies for any workers' compensation or occupational disease act or law, whether or not the covered person applied for coverage.
2. Services:
  - a. That are free or that a covered person would not be required to pay for if they did not have this insurance, unless charges are received from and reimbursable to the United States government or any of its agencies as required by law;
  - b. Furnished by, or payable under, any plan or law through any government or any political subdivision (this does not include Medicare or Medicaid); or
  - c. Furnished by any U.S. government-owned or operated hospital/institution/agency.
3. For covered persons who are serving in the armed forces, any loss caused or contributed by:
  - a. War or any act of war, whether declared or not;
  - b. Any act of international armed conflict; or
  - c. Any conflict involving any international authority.
4. Failure to keep an appointment with the provider.
5. Any service we consider cosmetic dentistry unless it is required as a result of an accidental injury sustained while the covered person is covered under the policy. We consider the following cosmetic dentistry procedures:
  - a. Facings on crowns or pontics (the portion of a fixed bridge between the abutments) posterior to the second bicuspid;
  - b. Any service performed primarily to improve appearance; or
  - c. Characterizations and personalization of prosthetic devices.
6. Charges for:
  - a. Precision or semi-precision attachments;
  - b. Any services for 3D imaging (cone beam images);
  - c. Additional charges related to materials or equipment used in the delivery of dental care;
  - d. Overdentures and any endodontic treatment associated with overdentures; or
  - e. Other customized attachments.
7. Any service related to:
  - a. Altering vertical dimension of teeth or changing the spacing and/or shape of the teeth;
  - b. Splinting teeth, including multiple abutments, or any service to stabilize periodontally weakened teeth, except for surgical and nonsurgical treatment of temporomandibular joint disorder and craniomandibular disorder; or
  - c. Replacing tooth structures lost as a result of abrasion, attrition, erosion or abfraction.

Except when necessary for the treatment of temporomandibular and/or craniomandibular disorders, any service related to:

- a. Restoration or maintenance of occlusion; or
  - b. Bite registration or bite analysis.
8. Infection control, including but not limited to sterilization techniques.
  9. Fees for treatment performed by someone other than a dentist except for scaling and teeth cleaning, and the topical application of fluoride that can be performed by a licensed dental hygienist. The treatment must be rendered under the supervision and guidance of the dentist in accordance with generally accepted dental standards.
  10. Any charges, including ancillary charges, made by a hospital, surgical center or similar facility, except for surgical and nonsurgical treatment of temporomandibular joint disorder and craniomandibular disorder.
  11. Prescription drugs or pre-medications, whether dispensed or prescribed.
  12. Any service that is not a dental necessity, or any dental procedures or dental treatments not approved by the American Dental Association or the appropriate dental specialty society.
  13. Orthodontic services unless otherwise stated in the "Pediatric Dental Benefit" section. Mail order self-administered orthodontics, not under the direction of a provider, are not covered.
  14. Any expense incurred before the covered person's effective date or after the date the covered person's coverage under the policy terminates.
  15. Services provided by someone who ordinarily lives in the covered person's home or who is a family member.
  16. Charges exceeding the reimbursement limit for the service.

Local anesthetics, irrigation, nitrous oxide/analgesia, bases, pulp caps, pulp testing, temporary dental services, study models/diagnostic casts, treatment plans, tissue preparation associated with the impression or placement of a restoration when charged as a separate service and desensitizing medicaments. These services are considered an integral part of the entire dental service.
18. Repair or replacement of orthodontic appliances.
19. Elective removal of non-pathologic impacted teeth.
20. Any non-emergent dental expenses incurred for services rendered outside of the United States.
21. Any services for tooth transplantation.
22. Any separate fees for pre and post-operative services.
23. Elective removal of non-pathologic impacted teeth.
24. Preventive control programs including, but not limited to, oral hygiene instructions, plaque control, take-home items, prescriptions, and dietary planning.
25. The replacement of any lost, stolen, damaged, misplaced or duplicate major restoration, prosthesis and/or appliance.
26. Caries susceptibility testing, lab tests, saliva samples, anaerobic cultures, sensitivity testing or charges for oral pathology procedures.
27. Partial ostectomy/sequestrectomy for removal of non-vital bone.
