

# Broker Guidance: Accepted Plans

## Please review this document in full for important guidance on selecting plans for your clients

- Our goal is for Patients to maintain their current doctor through this transition; we ask that you work with your clients to determine the best plan for their personal health needs
- TVH's accepted plans for will remain unchanged through 12/31/25
- CenterWell is expanding the The Villages Health's payer network to include Aetna, CarePlus, & additional Humana plans (see grid on following page)
- **UnitedHealthcare (UHC) plans will be *accepted through December 31, 2025*.** CenterWell is in ongoing discussions with UHC for a potential agreement for 2026 and beyond. If no agreement is reached, we will be unable to accept UHC plans starting January 1, 2026
- **For Aetna and CarePlus plan enrollment, please follow the steps outlined on page two of this document.** Due to credentialing, your client will need to select Dr. Soett Ramirez as PCP during AEP while we navigate this transition. Your patient can keep their current/preferred TVH PCP. We will work with your client to complete a PCP change once the providers are all loaded to the payer systems in the new year.
