A well-child visit is available to your Humana Healthy Horizons[®] in Florida-covered patients from birth through age 20. We're here to help you encourage Humana Healthy Horizons in Florida members to complete their routine health screenings to identify and correct medical conditions before they become more serious. As part of Florida's Early and Periodic Screening, Diagnosis and Treatment (EPSDT) program, a well-child visit is a good time to do so.

Making the most of the visit while the child is in the office

Some patients have a hard time getting to the doctor's office, so it's important to maximize each visit. There may be times when a well-child visit is appropriate even if the patient shows some mild symptoms of illness (e.g., runny nose/cold).

Components of a well-child visit

- Appropriate immunizations
- Comprehensive unclothed physical examination
- Dental screening, including dental referral, when required
- Developmental assessment
- Diagnosis and treatment
- Gathering of comprehensive health and developmental patient history, including assessment of past medical history, developmental history and behavioral health status
- Health education and anticipatory guidance
- Hearing screening, including objective testing, when required
- Laboratory test, including blood lead testing, when required
- Nutritional assessment
- Referral and follow-up, as appropriate
- Vision screening, including objective testing, when required

Importance of lead testing

Federal regulation requires all children to receive a blood test for lead at:

- 12 months old and 24 months old
- 36 months old and 72 months old for children who have not had a previous blood lead screening

How do well-child visit measures compare to the Healthcare Effectiveness Data and Information Set (HEDIS®) measures?

Components of the well-child visit and various HEDIS measures address annual wellness visits for children:

- Well-child visits in the first 30 months of life (W30)
- Child and adolescent well-care visits (WCV)
- Adults' access to preventive/ambulatory health services (AAP)
- Lead screening in children (LSC)

The main difference between the well-child visit measures and related HEDIS measures is based on the child's continuous enrollment in the plan, as well as the measurement periods for both groups of measures. With well-child visit measures, children are placed in the health plan's denominator (children meeting criteria for the service) once the child has been enrolled for at least 90 days. The measurement period is Oct. 1 through Sept. 30. HEDIS measures typically place children in the health plan's denominator once the child has been with the plan for 12 months. The timeline for many HEDIS measures is Jan. 1 through Dec. 31.

Most procedure codes detailed below cover both well-child visit and HEDIS measures, depending on care rendered to the member.

Members on the HEDIS and Child Health Check-Up (CHCUP) visits action lists you receive monthly and quarterly, respectively, may overlap based on the criteria detailed above about continuous enrollment and measurement periods. In addition, compliance also may be met with one visit based on the well-child visit time frames listed below.

The Humana Healthy Horizons in Florida approach to improve well-child visit measures

Humana Healthy Horizon in Florida is works to improve well-child visit measures using a variety of methods, including:

- Nurses who work directly with physician practices to promote well-child visits and improve HEDIS scores
- Outreach to patients using printed materials, online information and phone calls
- Patient reward programs through which eligible Medicaid members can earn rewards for receiving certain immunizations, screenings and wellness visits

Referral codes

According to the Agency for Health Care Administration (AHCA) Handbook's Evaluation and Management Services Coverage Policy, physicians and other health care professionals must include the following wellchild visit referral codes, as appropriate, on the claim form:

- AV Available-not used (recipient refused referral)
- NU Not used (no EPSDT recipient referral given)
- S2 Under treatment (recipient currently under treatment for referred diagnostic or corrective health problem)
- ST New service requested (recipient referred to another provider for diagnostic or corrective treatment or scheduled for another appointment with screening provider for diagnostic or corrective treatment for at least one health problem identified during an initial or periodic screening service, not including dental referrals)
