



SSI Medicaid Prior Authorization Metrics for medical items and services (excluding drugs)

To comply with the CMS Interoperability and Prior Authorization final rule, Humana is required to annually report aggregated prior authorization metrics on our website. The contract covered in this report is administered by iCare (Independent Care Health Plan), a wholly owned subsidiary of Humana. Specifically, this includes a list of all medical items and services (excluding drugs) that require prior authorization, as well as data on prior authorization requests for those items and services (e.g., approvals, denials, etc.) over the previous calendar year. Prior to January 1, 2026, Medicaid Managed Care Organization (MCO) plans are required to send prior authorization decisions within the following timeframes:

- 72 hours for **expedited requests** (urgent)
- 14 calendar days for **standard requests** (non-urgent)

Beginning January 1, 2026, the CMS Interoperability and Prior Authorization final rule requires MCO plans to send prior authorization decisions within:

- 72 hours for **expedited requests** (urgent)
- 7 calendar days for **standard requests** (non-urgent)



 86.72% of those requests were approved:**




The mean (average) time that it took to make standard prior authorization decisions was 6 day(s)

The median (middle) time that it took to make standard prior authorization decisions was 5 day(s)

In 2025, we received a total of 231 expedited (urgent) prior authorization requests for our covered patients. 81.39% of those requests were approved:

The median (middle) time that it took to make expedited prior authorization decisions was 12 hour(s)
